Minutes of the Raleigh Charter High School Board of Directors Meeting 25 August 2025

The Raleigh Charter High School Board of Directors meeting began at 5:30 p.m. and was conducted in virtual meeting format and was conducted contemporaneously with the Raleigh Charter High School Foundation, Inc. Board of Directors (the "Foundation Board"). Meeting notice was made on the School Main Calendar posted on the publicly accessible School website (www.raleighcharter.org).

Those in attendance and constituting a quorum were:

Except where noted below, the meeting followed the Agenda, which was distributed at the meeting, a copy of which is attached to these Minutes.

Welcome: Foundation Board Chair welcomed all the Raleigh Charter High School Board Members as they joined the Foundation Board meeting in progress. Chair J. Marks of the School Board welcomed the members and guests joining the meeting.

Finance: J. Green was recognized to present an update from the Finance Committee. He displayed the 2025-2026 RCHS Budget as approved and noted that there are no changes yet to expected expenses for the school year. More information regarding funding from the State and County is expected in September and will be updated at the next board meeting. A. Keyworth asked a question regarding utility costs and expressed an opinion that costs would likely increase more than 3% in October of 2025.

Fundraising for the Foundation has been excellent over the last two years. The Foundation is now in the position to retire the educational facilities bond and has a plan in place to do so in the coming months. D. Ennis has evaluated logistics and paperwork and will proceed with necessary steps to retire the bond after state funds are received this fall.

J. Green also discussed the Foundation Budget for 2025-2026 and noted that the expected fundraising contributions will be lower this year, and the interest expense due to the school loan will also be less, once the note is paid off.

The Finance Committee presented the following: The Foundation Finance Committee recommends that the RCHS Foundation Board of Directors authorize RCHS staff to fully retire the educational facilities bond using Foundation funds, contingent upon the School receiving funding from the State of North Carolina and Wake County that meets budgetary expectations.

The Foundation Board members voted unanimously to accept the recommendation of the Foundation Finance Committee.

The RCHS School Board Chair called for a motion and vote on the same plan to retire the facilities bond. On proper motion by J. Marks and second by J. Green, the RCHS School Board of Directors unanimously voted to authorize RCHS staff to fully retire the educational facilities bond using Foundation funds, contingent upon the School receiving funding from the State of North Carolina and Wake County that meets budgetary expectations.

A copy of the 2025-2026 Budget as presented is attached to these minutes.

Development: J. McDonald was recognized to present an update on fundraising efforts. She reported that both the Phoenix Fund and the Foundation Fund were very successful last year. The reports for both funds are attached to these minutes. We still need to raise \$365,000 to reach our \$1.5 MM goal for the Foundation Fund. A generous donor is offering to match significant gifts through the end of 2025. More information will be coming soon. The Chair asked all members of the Foundation Board and the School Board to consider giving to our fundraising efforts this year with a goal of 100% participation by the end of October 2025.

Phoenix Parents: A. Flynn provided an update on Phoenix Parents activities. She noted that Parents helped organize and provide volunteers for classroom preparation days, building and grounds clean up/improvements, and they helped with Orientation Day by staffing the course pack sales. Many upcoming events are on the calendar including the 3rd Friday Club Fair, Back to School Night, and a Phoenix Parents Social event, all of which are also noted in the Principal's Report.

Principal's Report: S. Klein, Academic Dean, was recognized to provide the Principal's Report. She distributed and led the Board in a discussion of the Principal's Report handout.

A copy of the Principal's Report handout as presented at the meeting is attached to these Minutes.

A. Keyworth asked about the enrollment numbers and S. Klein clarified that generally it is hard to enroll new students who are in 11th grade, even though spots might be available due to students transferring out to the NC School of Science and Math. The school currently has a higher number of students enrolled versus the 2024-2025 school year and the additional funding that should be allocated is expected in October or November.

S. Klein asked the Board to review the Student and Faculty Handbooks as they will need to be approved during the September board meeting.

Adjourn: Upon proper motion by P. McSorley and second by A. Karsten, the Foundation Board voted unanimously to adjourn at approx. 6:15 p.m.

Minutes of the 23 June 2025 Meeting of the Board: The Board reviewed the draft minutes of the 23 June 2025 meeting of the Board. Upon proper motion by R. Fenoglio and second by J. Marks, the Board unanimously approved the minutes of the 23 June 2025 meeting of the Board as written.

Reminders: J. Marks reminded the Board of a few items to note as we begin the new academic year. Each Board member should complete the Conflict of Interest form which can be found in the Board Google folder. Also, Board members are asked to consider making a financial contribution to the Phoenix Fund or Foundation Fund this year. Finally, Board members will be asked to serve on a committee in the coming weeks and months.

J. Marks expressed gratitude to the staff and administrators who have served the school in an exemplary way during the beginning of the school year and have offered great support to L. Huddleston during this difficult time in her personal life.

Dates for upcoming meetings: Meeting dates will be posted on the School Calendar and are expected to be once a month. Next meeting will be 29 September 2025.

Closed Session: On proper motion by N. Robson and second by D. Thompson the Board unanimously voted to enter Closed Session to consider personnel matters and to allow D. Ennis to remain for technical support and Academic Deans S. Klein and C. Setubal to attend.

On proper motion by A. Karsten and second by R. Fenoglio the Board unanimously voted to leave Closed Session.

On proper motion by S. Headen and second by R. Fenoglio the Board unanimously voted to approve the hiring of Angelique Alexander as a Math Teacher effective 1 August 2025.

On proper motion by A. Marschall and second by N. Robson the Board unanimously voted to approve the hiring of Stephen Meyers as Women's Tennis Coach effective 1 August 2025.

On proper motion by C. Finch and second by J. McDonald the Board unanimously voted to adjourn at 6:36 p.m.

General

• Shayne Klein continues to work with our new staff members to introduce them to our culture and to connect them with our community. In addition to the new hires, Shayne includes second-year staff in these meetings.

- During our August faculty meetings, we worked together to discuss deep learning and the challenge of AI, honor, orientation, extended advisory, working with children with disabilities, and safety. Departments and committees began meeting as well.
- Sarita McIver, Rebecca Flammia, Shayla Coleman, and Sera Arcaro manage and organize our Peer Mentoring program, in which our juniors and seniors work with our new students - both ninth graders and transfers - at Orientation and in Advisory to help them adjust to high school and learn about our school culture.
- During four Extended Advisory times at the beginning of the year, students and teachers worked to get to know one another, review the student handbook, complete safety drills, and play a variety of games together.
- On Friday, August 29, the third Friday of the school year, we will hold our annual Club Fair and Pizza Sale. Classes will dismiss at 1:05, and students will have the chance to visit booths and eat pizza together. To prepare for this event, club leaders and advisors met together on August 22, the second Friday of the year, to plan and prepare for club activities.
- Thank you once again to our parents and families for their invaluable assistance as we began the school year. Just some of what they have accomplished includes:
 - They thoughtfully provided multiple meals as faculty gathered at the beginning of the year.
 - Parents also staffed the course pack sale, managed the carpool database and parking lottery for our students, volunteered for indoor and outdoor work days, and are organizing pizza and drinks for our Third Friday celebration.
- RCHS was once again ranked in the US News and World Report's list of top public high schools. The school was placed #206 in nation, #49 amongst charter schools, #5 public high school in North Carolina, and #70 in STEM High Schools. https://www.newsobserver.com/news/local/education/article311769989.html?

College Counseling Report

- Class of 2025: The 125 students in the Class of 2025 submitted a total of 822 applications to 217 colleges located in 37 states, the District of Columbia, plus 2 countries. They were accepted into 181 different colleges spanning 33 states, the District of Columbia, plus 2 countries. Graduating seniors matriculated into 41 different colleges. Scholarships awarded totaled over \$3.6 million. One major scholarship awarded included the Cheatham-White Scholarship at North Carolina Central University, which was a first for Raleigh Charter.
- Class of 2024: The 136 students in the Class of 2024 submitted a total of 944 applications to 166 colleges located in 35 states, the District of Columbia, and three other countries. They were accepted into 136 different colleges. Graduating seniors matriculated into 44 different colleges. Scholarships awarded totaled almost \$8 million. Major scholarships awarded included the Park Scholarship at NC State University, the Levine Scholarship at the University of North Carolina at Charlotte, the Kenan Music Scholarship at the University of North Carolina at Chapel Hill, the Stamps Scholarship at Wake Forest University, the Dozoretz National Institute for Mathematics and Applied Sciences (DNIMAS) at Norfolk State University, and the Jack Kent Cooke Scholarship.
- Class of 2023: The 132 students in the class of 2023 applied to 202 colleges and will enroll in 42 different colleges. Scholarship awards for this class totaled over \$7.7 million,

- and the graduates accepted over \$1.8 million. Major scholarships awarded included a Park scholar (NCSU), a Levine scholar (UNC Charlotte), and a UNC Chancellor's Science scholar.
- Class of 2022: The 130 students in the class of 2022 applied to 157 colleges in 37 states and 3 countries (Ireland, Canada, and the US) They were accepted at 104 different colleges and universities and matriculated at 37 different colleges in 19 states.
 Scholarship awards for this class totaled over \$3.5 million. There were two military academy appointments and several large scholarships including a Morehead-Cain, a Park, and a Stamps.
- Class of 2021: The 138 students in the Class of 2021 applied to 180 colleges in 36 states and 3 countries and were accepted to 128 different colleges and universities and matriculated at 41 different colleges in 29 states and 3 countries. Scholarship awards totaled over \$6 million.
- Class of 2020: The 136 students in the Class of 2020 applied to 144 colleges in 33 states and were accepted at 84 different colleges and universities. They matriculated at 32 different colleges in 12 states and 2 countries. Scholarship awards totaled over \$6 million.

Handbooks for 2025-26
