Minutes of the Raleigh Charter High School, Inc. Board of Directors Meeting 22 May 2023

The Raleigh Charter High School, Inc. Board of Directors meeting began at 5:33 p.m. in virtual meeting format. Meeting notice was made on the School Main Calendar posted on the publicly accessible School website (www.raleighcharterhs.org). Those in attendance and constituting a quorum were:

Except where noted below, the meeting followed the Agenda which was distributed at the meeting, a copy of which is attached to these Minutes.

Welcome: The Chair welcomed all the Raleigh Charter High School Board Members.

Minutes of the 27 March 2023 Meeting of the Board. The Board reviewed the draft minutes of the 27 March 2023 meeting of the Board. On proper motion by J. Green and second by J. McDonald, the Board unanimously approved the minutes of the 27 March 2023 meeting of the Board as written.

Finance Committee: J. Green was recognized to provide a report from the Finance Committee:

- This is an exciting time for the committee as they get closer to understanding the final numbers for the year, which is allowing them to look at options for the second teacher bonus.
- Budget updates as presented:
 - Funding from the State has increased by \$15,000 and funding from the county has increased by \$2,000
 - The Federal Funding earmarked for COVID fund spends have been zeroed out as the school is unable to find proper ways to spend it. These funds were only available if they are spent on designated expenditures.
 - Sports Donations are down by \$15,000 versus what was expected at start of the year
 - The Phoenix Fund revenue has been brought down to \$265,000 as will be explained in the Development Committee update
 - An increase in Interest Income of \$16,000 is reflected
 - The total decrease in expected revenue is \$118,000 of which \$107,000 is from the inability to properly use the \$107,000 in potential Federal COVID funds
 - On the expense side, we have a clearer picture of the actual spends for the year and the following adjustments were made:
 - Utilities expense expected to be \$30,000 lower than forecasted
 - Maintenance expenses will be \$15,000 lower than forecasted
 - There are some small changes to the Personnel and Instruction expenditures
 - The total expected decrease in expenses will be \$20,000

- The Foundation transfer to the school has been increased by \$22,000 to reflect the income and expense changes. With that change, our debt service coverage remains in good shape.
- The committee had a preliminary discussion about the 2023-24 budget and will plan to present a detailed proposal at next month's Board meeting
- The committee will continue to work on proposed faculty bonuses looking at multiple options to determine the maximum that can be done. A proposal will be delivered at next month's Board meeting.

Chair mentioned that this past month's Finance Committee meeting went very well and he appreciates their work to develop a meaningful bonus proposal.

A copy of the Raleigh Charter High School 2022-23 Budget as reviewed at the meeting is attached to these minutes.

Development Committee: R. Mann-White was recognized to provide an update from the Development Committee. She reported on the following items:

- It is projected that we will not be as successful with the Phoenix Fund as we have been in the past. As of 16 May 2023 we are forecasting \$264,000 with \$253,000 received, which is 82% to our goal.
- Our first Day of Giving was successful:
 - We received some gifts in honor of graduating seniors
 - \$20,112 was raised for the Phoenix Fund
 - \$7,671 was raised for the Foundation Fund
 - The Day of Giving "By the Numbers" was shared
- The Foundation Campaign is 27% fulfilled as of 16 May 2023. Alumni were encouraged to give to the Foundation Campaign at the recent Alumni event and we received 3 gifts that day.
- The next Development Committee meeting 24 May 2023 and all interested members of the Board are invited to attend.

A copy of the Phoenix Fund Report, The Day of Giving "By the Numbers", and Foundation Campaign Update as reviewed at the meeting is attached to these minutes.

Diversity Committee: Member P. Smith was recognized to provide an update on the Diversity Committee. He reported the following items:

- The final meeting of the Committee was held earlier today
- This past year, the Committee was very engaged and had an active Parent Diversity Network
- The school showed great support over the past year, especially the Affinity Groups which recently held year-end celebrations
- AAPI events occurred over this past month
- The Committee has been and will continue to be present at New Family events
- The next committee meeting will be held in August with the start of the new school year

Phoenix Parents: A. Tate was recognized to provide an update on behalf of the Phoenix Parents organization. She reported the following items:

- The last meeting of the year was held in April. A group will be meeting in May to prepare for the first day of school course-pack sales, indoor & outdoor workdays, etc.
- The slate of officers and positions for next year is almost full; there is some room for new parents to get involved as they join the community.
- The meeting minutes are posted in the Board folder
- The budget will be completed in June as they bring on board a new Treasurer

Principal's Report: L. Huddleston was recognized to provide the Principal's Report. She distributed and led the Board in a discussion of the Principal's Report handout.

Member P. Murray asked if the school would like Board Members to attend the new parent night on 6 June 2023 as had been the case before COVID. L. Huddleston responded that Board member attendance is encouraged and welcomed.

A copy Principal's Report handout as presented at the meeting is attached to these Minutes.

Additional Business / Public Comment: The Chair opened the floor to entertain additional items of business not covered in the meeting agenda. No Public Comments were raised.

Chair recognized member P. Murray who asked about the proposed changes to the NCHSAA and it's potential impact on Raleigh Charter High School sports. L. Huddleston responded that with the North Carolina Legislature getting involved, it will depend on what gets passed. Our school has seen some success at the 2A level, however is the proposed changes are passed and the school is moved to 4A, we would hope that we can work with other schools to have a conference established so that we can be competitive within a conference. Now that the Legislature is involved, we will have to see how it plays out.

Chair recognized member P Murray who asked if our school will see any of the funds from the North Carolina Attorney General's settlement with Juul. L. Huddleston responded that it will depend on whether the counties decide to allocate any of it to the Charter Schools in their districts.

Board Meeting Schedule: Chair was recognized to discuss the upcoming Board Meeting schedule:

- Our next meeting will be on 26 June 2023, it will be our final meeting of the school year-end
- It will be a joint meeting with the Foundation Board
- It will be conducted over Zoom

Closed Session: On proper motion by P. Murray and second by P. Smith, the Board unanimously voted to enter Closed Session to consider personnel matters and to allow D. Ennis to remain for technical support, S. Klein to attend since she is Academic Dean, and N. Pedersen to attend in her role as the Faculty representative.

On proper motion by P. Murray and second by D. Thompson, the Board unanimously voted to leave Closed Session.

On proper motion by J. McDonald and second by S. Headen, the Board unanimously voted to approve the hiring of Owen Asplundh as a History teacher.

On proper motion by P. Murray and second by J. McDonald, the Board unanimously voted to approve the hiring of Karima Elmaghraby as a History teacher.

On proper motion by P. Smith and second by S. Headen the Board unanimously voted to adjourn at 6:18 p.m.

Principal's Report for Raleigh Charter High School Board of Directors' Meeting on May 22, 2023

General

- The fifth grading period ended on Friday, March 31, and report cards went home with students after Spring Break on Friday, April 14.
- We have had three Admitted Students Open Houses for our incoming students: April 12, May 10, and May 12. Thank you to Shayne Klein and Caio Setubal for setting up and presenting at these events. In addition, a number of faculty and students assisted by answering questions, giving tours, and running a club fair. We appreciate all the hard work to prepare for the Class of 2027.
- On Friday, April 14, the 58 Honors Civic Literacy students participated in our annual schoollevel *We the People* competition. We appreciate the support of the many volunteers who came in to judge for this event, and thank you to Melani Winter for her hard work in once again preparing her students and organizing the day.
- Our spring Community Work Day occurred on Friday, April 21. Thank you to Hannah Fatool and Hikaru Wajima for their behind-the-scenes work to make this day go smoothly.
- The students in our Constitutional Issues class attended the national We the People competition in Washington, DC from April 21 through April 25. The students represented North Carolina well, including winning one of the awards for the best unit at the national level! Thanks to Shayne Klein for her work as the teacher of this class and to Caio Setubal and Mimi Tomei for chaperoning.
- Our music programs Strings (April 27), Choral (May 16), and Band (May 18) held their annual spring concerts over the last few weeks at the Kenan Recital Hall at William Peace University. Thank you to Cynthia Brown and David Kilbride for their leadership of these programs.
- AP Exams took place at Royal Banquet, the Pullen Community Center, Hayes-Barton Baptist Church, and on campus and have now concluded. The regular administration window was May 1-12, and the make-up exams were last week. Thank you to the many staff members, substitutes, and volunteers who made this possible.
